Respected Sir,

MNRE has issued OM on 17-05-2023 regarding revision in procedure for Empanelment of Vendors under Simplified procedure of Rooftop Solar Program Phase-II on National Portal. Copy of same is enclosed herewith.

This OM provides that vendors shall have to submit only a single PBG of Rs.2.5 lakhs for the entire State.

In above regard, considering suggested options mentioned under Para (3) of aforesaid OM, the registration procedure of vendors in the DISCOMs of Gujarat State for National Portal is as under:-

- 1. Vendor shall register their application along with declaration & required documents as per MNRE's guidelines in the concerned DISCOM in whose jurisdiction the Vendor's Corporate office is situated.
- 2. Respective DISCOM will collect the PBG from the vendors on behalf of all DISCOMs including Torrent Power Ltd.
- 3. The DISCOM collecting the PBG will register the vendors for entire State Gujarat and provide a list of registered vendors (updated periodically) to other DISCOMs including Torrent Power Ltd for uploading the same on their respective National Portal accounts.
- 4. UGVCL and DGVCL shall register the application of vendors whose Corporate office is situated in jurisdiction of Torrent Power Ltd –Ahmedabad and Torrent Power Ltd –Surat respectively.
- 5. For those Vendors, whose Corporate office is located outside the Gujarat state, they shall register their application with GUVNL DISCOMs (as per attached map).
